VISA DOCUMENTATION To be eligible to apply, your salary offer must be at least US\$25,000.00 per annum: - Employment contract duly signed by the employer and employee - Employment contract must be on a non-judicial stamp paper - Proof of registration/incorporation of company with the Government of India. - Letter on employer's letterhead indicating nature of job, salary structure and duration of contract. - Resume of applicant with a copy of relevant credentials - For Teaching Jobs: Letter of appointment from the school and No-objection Certificate from the Ministry of Human Resources and Development, New Delhi.
