Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

- 1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
- 2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
- 3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.
- 4. THE HIGH COMMISSION OF INDIA RESERVES THE RIGHT TO CALL FOR ADDITIONAL DOCUMENTS, AS CONSIDERED NECESSARY.
- 5. PLEASE BE ADVISED THAT THIS IS NOT AN E-TOURIST VISA APPLICATION.
- 6. A Tourist visa can be **applied for up to 1 year and** is valid from the date of issue. **The duration of the Visa is subject to the discretion of the "High Commission of India".**
- Please check the 'Sample Form' available on <u>www.blsindia-canada.com</u> for guidance on filling up your application.
- 8. Ensure that you apply for a Visa at least 2 weeks before your flight arrangements for Canadian passport holders only. (Processing time differ for Non-Canadian Passport holders).

Important:

- 1. If you cannot visit the VAC, it is recommended that you use the postal service to submit your application.
- 2. Alternatively, to book a pickup and/or drop via Purolator, visit http://www.blsindia-canada.com/vas/
- 3. Foreign visitors to Canada cannot apply for Indian visa services in Canada.

Please fill the online application form as per your passport. After submission online, no changes can be made. In case of an error, please fill a new online application form. Please note: BLS International employees cannot edit or make any changes to your online application form.
 Photograph: One photo of size 51mm x 51 mm. Paste this on Page 1 of the Application Form. (It is not compulsory to upload your photograph online, unless you are applying for an E-Tourist Visa). Signature Instructions: - Sign at Page 1, inside the box, below your photo, and at Page 2. Signature must match with your current passport. - Minor Applicants (Below 18 Years): (For further documentation for minors, please refer to page 2) - Signature must match with the valid passport. - If a minor cannot sign, using only black or blue ink, apply left hand thumb impression for boys & right for girls at Pages 1 & 2. - Both parents must also sign below the applicant's signature on Page 2.
Documents: Provide photocopies, unless otherwise stated, of the below documents on A4 size paper. If applying in person at a BLS Center, you are also requested to carry the originals of the photocopies provided for verification purposes only. - All photocopies have to be self-attested
Canadian/Foreign Passport (Original): - Must be valid for at least 190 days. - Must have at least two blank/unstamped pages.
