Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

- 1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
- 2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
- 3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.

Important:

- 4. If you cannot visit the VAC, it is recommended that you use the postal service to submit your application.

- 6. Foreign visitors to Canada cannot apply for Indian visa services in Canada

• An OCI Card may be approved and is valid for a life time. It must however be replaced each time a new passport is issued up to Completion of 20 years of age, and once after completing 50 years.

Online Application Form: Application must be completed and submitted online by visiting: https://passport.gov.in/oci/ This application is in two parts — Part A and B. Both must be completed. As part of the registration process, the supporting documents have to be uploaded using the same registration number. For Minors applying individually without parent applications, please submit Part A and Part B forms separately. ***If minors are applying with parents as primary applicants, Part A has to be individually filled and 1 common Part B form can be submitted for all family applicants. For adult unmarried applicants, please fill separate forms for Part A and Part B. Be sure to also select the correct Indian mission based on the place where you reside in Canada, and the mission's jurisdiction. Mission jurisdiction can be viewed at: http://www.blsindia-canada.com/ocihome.php Please print applicant's name, place of birth, date of birth, passport issue according to Canadian/ Foreign passport and Parents, spouse name according to Indian Passport or it has to be as per foreign passport if any. In case of an error, please fill a fresh new online application.

If the consulate is not able to read the contents and/or recognize the photograph on the photocopies, the application will be returned to you without processing. Record of landing (IMM1000)/ Confirmation of Permanent Residence (IMM 5392) - All the applicants who are born outside Canada must submit Record of landing/Confirmation of permanent Residence showing immigration category of the applicant.
- In case of unmarried/single applicants who migrated to Canada on PR status as minors with their parents, they should submit their parent's landing documents. This is not required in case of an applicant who migrated to Canada independently as an adult without their parents.
 In case of a married applicant, spouse's landing papers are required even if the spouse is not applying for OCI. In case the applicant is divorced, please bring the Divorce certificate, duly attested, in English only; the same can be accepted in lieu of the landing papers of his/her previous spouse.  In case of applicants who are born in Canada and have acquired Canadian citizenship by birth, their Statement of Live Birth showing both the parents' name is required along with Parent's landing papers. If the parents/spouse has never landed in Canada an affidavit to this effect should be submitted.
- In case, original landing paper is not available / lost, a duplicate/certified true copy or any other document, showing applicant's immigration category, issued by Canadian immigration authority can be accepted. Please note that the document submitted in lieu of the lost/misplaced original landing document will be accepted only if it reflects the immigration category of applicant.
FC/Family Category on Landing Paper: If you immigrated in Canada under Family Class (FC) immigration category and if your previous sponsors and their respective sponsors (up to 3 generations) migrated to Canada on the same FC category, please provide; Indian Passport of sponsor (Copy) Landing Paper of Sponsor(Copy)
 If all 3 generations are Family Class (FC Category), you are required to provide A Notarized affidavit for up to 3 generations (i.e. name of the sponsors down 3 generations detailing who sponsored whom), along with their Names and declaring the "Specific categories" basis which they have entered Canada as per their landing paper. In addition, you are also required to provide a letter from the Refugee Board of Canada - 'atip@irb-cisr.gc.ca' along with the above notarized affidavit for Non Refugee status.***
Citizenship Certificate - A citizenship certificate issued by the Canadian authority mentioning the exact date of acquiring the Canadian citizenship is required. In case citizenship certificate/exact date of acquiring Canadian citizenship is not reflected in the citizenship certificate or citizenship card, the applicant may submit an undertaking giving the exact date of acquiring Canadian Citizenship. However, if the applicant is unable to provide the exact date, a Search letter or any other document issued by the concerned Canadian authorities mentioning the exact date (i.e. date, month and year) should be submitted.
Marriage Certificate Spouse name should be entered in the Indian Passport if the applicant is married. If spouse name is not entered in their respective partner's Indian passport, then their marriage certificate should be issued by a competent Government authority, stamped by the Marriage Registrar and by Ministry of External Affairs, New Delhi.
Please note: - If a Minor applicant is applying with or without parents, the spouse names <i>of either parent</i> should be entered in the Indian passports if not then marriage certificate has to be attested by Ministry of External Affairs, New Delhi. If one partner's name reflects in other partner's Indian passport then applicant must submit Marriage certificate from Registrar with notarized joint affidavit containing joint photograph and Signatures from Notary Public or lawyer in Canada.
If applicant does not have marriage certificate attested by MEA (Ministry of External Affairs) New Delhi, then it can be accepted along with notarized joint affidavit containing joint photograph and Signatures from Notary Public or lawyer in Canada. - If married in India:


