

# TOURIST VISA CHECKLIST



PLEASE ATTACH A COPY OF THE CHECKLIST WITH EACH APPLICATION AND CHECK MARK ALL THE REQUIREMENTS BELOW THAT ARE COMPLIED WITH. SIGN AT THE END OF EACH PAGE OF THE CHECKLIST.

### PLEASE NOTE

- THE CONSULATE RESERVES THE RIGHT TO CALL FOR ADDITIONAL DOCUMENTS, AS CONSIDERED NECESSARY.
- PLEASE BE ADVISED THAT THIS IS NOT AN E-TOURIST VISA APPLICATION.
- A Tourist visa can be applied for up to 1 year and is valid from the date of issue. The duration of the Visa is subject to the discretion of the Consulate General of India.
- Please check the 'Sample Form' available on [www.blsindia-canada.com](http://www.blsindia-canada.com) for guidance on filling up your application.
- Ensure that you apply for a Visa at least 2 weeks before your flight arrangements for Canadian passport holders only. (Processing times differ for Non-Canadian passport and Canadian travel document holders).

### Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.

<input type="checkbox"/>	<p><b>Additional documents for MINOR applicants (Below 18 Years):</b></p> <ul style="list-style-type: none"> <li>- Valid passport copies of both parents.</li> <li>- Minor Consent Form – duly completed and signed by both parents. This can be obtained from <a href="https://www.blsindia-canada.com/forms/HCI-CGI_Minor%20consent%20form.pdf">https://www.blsindia-canada.com/forms/HCI-CGI_Minor%20consent%20form.pdf</a></li> <li>- Statement of Live Birth Certificate reflecting both parent’s names</li> </ul> <p><b>For Minor travelling without parents, please provide;</b></p> <ul style="list-style-type: none"> <li>- Notarized Affidavit indicating their consent to travel. Both parents need to sign on the affidavit.</li> <li>- Passport photocopy of the person travelling with the minor.</li> </ul> <p><b>If either parent is out of the country, please provide the following additional documents;</b></p> <ul style="list-style-type: none"> <li>- Notarized Affidavit indicating consent given to spouse to travel with minor.</li> <li>- Notarized passport photocopy in original of the parent who is abroad. This can be obtained from Notary Public.</li> </ul> <p><b>If either parent is divorced,</b> Divorce Certificate and Court Custody papers are required (specifically mentioning the clause that indicates which parent has custody &amp; consent to make travel arrangements for the child).</p>

The Mission may also request for additional documentation at any time during or after the submission of the application.
