If applying in person at a BLS Center, you are also requested to carry the originals of the photocopies provided for verification purposes only. If you have lost your last held Indian passport, please visit the Consulate General of India directly.
Foreign / Canadian Passport: Copy of photo page and observations (if any) of your current valid foreign / Canadian passport. If you have not applied

for your passport, please write a written declaration to the Consulate General of India with an explanation of the same.
CITIZENSHIP OATH CERTIFICATE: A citizenship / Oath certificate issued by the Canadian authority mentioning the exact date of acquiring the Canadian citizenship is required. In case citizenship certificate/exact date of acquiring Canadian citizenship is not reflected in the citizenship certificate or citizenship card, the applicant may submit an undertaking giving the exact date of acquiring Canadian Citizenship. However, if the applicant is unable to provide the exact date, a Search letter or any other document issued by the concerned Canadian authorities mentioning the exact date (i.e. date, month and year) should be submitted.
