PLEASE NOTE

- THE CONSULATE RESERVES THE RIGHT TO CALL FOR ADDITIONAL DOCUMENTS, AS CONSIDERED NECESSARY.
- PLEASE BE ADVISED THAT THIS IS NOT AN E-TOURIST VISA APPLICATION.
- A Tourist visa can be applied for up to 1 year and is valid from the date of issue. The duration of the Visa is subject to the discretion of the Consulate General of India.
- Please check the 'Sample Form' available on www.blsindia-canada.com for guidance on filling up your application.
- Ensure that you apply for a Visa at least 2 weeks before your flight arrangements for Canadian passport holders only. (Processing times differ for Non-Canadian passport and Canadian travel document holders).
- Walk – in Applicant must visit BLS centers in person as Biometrics is mandatory (this applies to applicants from 12 years to 70 years of age) (biometrics exempted for 1 year Postal applications)

Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.
4. If you cannot visit the VAC, it is recommended that you use the postal service to submit your application. Alternatively, to book a pickup and/or drop via FedEx, visit <http://www.blsindia-canada.com/vas/>

After submission online, no changes can be made. In case of an error, please fill a new online application form. Please note: BLS International employees cannot edit or make any changes to your online application form. - Please note: You may be called for an interview or may require a pre-approval from the Consulate General of India, Toronto.

This can be obtained from https://www.blsindia-canada.com/forms/HCI-CGI_Minor%20consent%20form.pdf - Statement of Live Birth Certificate reflecting both parent’s names <p>For Minor travelling without parents, please provide;</p> <ul style="list-style-type: none"> - Notarized Affidavit indicating their consent to travel. Both parents need to sign on the affidavit. - Passport photocopy of the person travelling with the minor. <p>If either parent is out of the country, please provide the following additional documents;</p> <ul style="list-style-type: none"> - Notarized Affidavit indicating consent given to spouse to travel with minor. - Notarized passport photocopy in original of the parent who is abroad. This can be obtained from Notary Public. <p>If either parent is divorced, Divorce Certificate and Court Custody papers are required (specifically mentioning the clause that indicates which parent has custody & consent to make travel arrangements for the child).</p>
