VISA APPLICATION

FORM FILLING INSTRUCTIONS

- All applications must be filled under **TORONTO**JURISDICTION.
- Applicant details on the form must match with your Current Passport.
- Prefix/Suffix is not acceptable with any name on the Application Form (For Example: SHRI, LATE, MR, MRS, ER, DR, MAJOR, SUBEDAR, SARDAR, COLONEL Etc.)
- If the photo to be uploaded is not as per specifications, kindly do not upload it and select "Skip and Continue" option.
- DO NOT mention "Pakistan" as country of birth on the application form, if parents were born before 1947 in a territory belonging to Pakistan. Mention UNDIVIDED INDIA instead of Pakistan.
- Postal applications are acceptable for the VISA
 validity up to 1 year only. For validity longer than 1
 year, applications must be submitted in-person.
- For Validity longer than 1 year, applicant must submit the Surrendered Indian Passport copy/ Surrender certificate as an addition document.
- Verifiable signatures of parents in Consent Form.

- All Journalists should apply for only "J" Visa (Single Entry with validity for 3 Months)
- Business Visa applications should be accompanied by invitation letter from India clearly mentioning the duration for which the visa is to be issued in addition to other requirements as per checklist.
- Conference Visa applications should be accompanied by clearance from MEA

Once the application is complete, applicant can visit the Consulate on Tuesday or Thursday between 9.30 AM - 11.30 AM along with all the documents for approval.
